Councils, areas, regions, and national may use this new award to recognize individuals for significant contributions such as contributing land for a new service center or for the CPA who has served the council for years or for use at a Distinguished Citizen Awards program. This award is on par with the Silver Beaver which recognizes registered Scouters for their distinguished service.

## INSTRUCTIONS

1. Using this nomination form **only**, provide the full name and title of the nominee exactly as it should appear on the certificate. Do not use abbreviations or nicknames.
2. Furnish as much information as possible as to why the nominee should be recognized. For example, owner of the company who donated land for a new service center or high adventure camp; doctor who has provided free physicals for Scouts for years and provides medical support for summer camp and camporees; president of the law firm that provides free legal services for the council; or, superintendent of schools who supports the council. Some honoree may be highlighted in *Scouting* magazine.
3. Nomination cannot be for posthumous awards.
4. This award is not to be used to supplement or replace the Silver Beaver Award. It is to recognize non-Scouters whereas the Silver Beaver recognizes registered Scouters.
5. Complete this nomination form insuring that the council awards chair and Scout executive have signed the form.

## North Star Award

The Boy Scouts of America through the National Court of Honor may award the North Star Award for distinguished service to Scouting by non-Scouters. This award is on par with the Silver Beaver which recognizes registered Scouters for their distinguished service.

### Procedure

1. The nomination shall be submitted to the National Court of Honor not less than 30 days in advance of the presentation using **only** this nomination form.
2. The award is presented to those non-Scouters (not registered) who provide distinguished service to Scouting.
3. There is no limit on the number of annual nominations.
4. The award consists of a silver eight pointed star with the fleur-de-lis in the center suspended from a black ribbon and certificate. Certificates are supplied by the national office at no charge to local councils. Each council will need to order medal # 610645 from the National Distribution Center.
5. It is recommended that presentations of this award be done at a high quality level such as at a council recognition banquet, public gathering, or event appropriate to the honoree. As an example, if you were recognizing the superintendent of schools, you might convene a Court of Honor at a school board meeting to make your presentation. You may also use this award at Distinguished Citizen Awards programs.
