July 31, 2023

- Updated/Revised the Charter Renewal Status Report with descriptive 'Status' definitions for "Waiting", "On Hold", "Locked", and "Posted"
- o Improved how multiples are validated
- o Added "Generate Charter" button with IR app

- Create more descriptive timeline
- Add Council Unit Representative to selectable positions
- Add validation for existing members
- o Fix bug with auto-post when multiples are present
- Provide different icons for IH/Executive Officer who don't need YPT

February 28, 2023

- Display country code for phone numbers on Validation and Pay page
- Added an additional check to ensure duplicate files are not uploaded for CBD and Adult applications
- When ACH fails, allowing unit to resubmit and select another method of payment

- o Removed incorrect year from recharter confirmation email

- Hide "Pay at Council" for Transatlantic Council
- Change age validation when adding new member to include future recharter timespan
- When changing from a Tiger Parent or Lion Adult Partner into a registered adult position, require paper application
- Change Validation for Unit has less than 2 paid youths from Warning to Error
- Show link file that displays signed recharter paperwork on confirmation page
- When ACH payment confirmation fails, revert recharter status to Initiated vs. On Hold or Waiting
- Show prepaid youth and adults in recharter paperwork
- o Add language to Update Member Information Modal to account for Participants
- Create page for unit treasurers to confirm microdeposits if they do not receive confirmation email from WePay
- Charge people with international address \$39.00 for Scout Life
- o Explain how to 2 linked units must pay online from the same bank account
- Change message for initiated manual recharters

August 31, 2022

August 1, 2022

- Added gender to roster report
- On the confirmation page at the end, we will be indicating who signed the recharter paperwork and when it was signed
- Units who did not have two primary youth in the unit will receive an error vs. a warning previously
- Units that have expired and are not rechartering will no longer be presented as units to be able to multiple into
- New fees are reflecting in recharter calculation
- Creating a page to submit microdeposit information to validate ACH payments, which will allow us to not rely on email from WePay that was periodically going to junk and spam email boxes
- Creating clearer instructions on documents requested for upload to avoid erroneous documents from being uploaded
- Removing "no extra fee" from UI and replacing "Local council processing fee may apply" to account for councils who add a fee for manual pay
- o Adding instructions for ACH payers to help understand additional steps
- Marking prepaid youth and adults on recharter paperwork
- o Adding language educating difference between participant and youth.
