



Venturing Range and Target Activities Outstanding Achievement Award

Rifles

1. Rifles

- a. Any safe .22 or .17 HMR caliber rimfire rifle may be used. For the Standing and 3-Position course the rifle must weigh 8.5 pounds or less, including sights and slings. Schuetzen type butt plates and palm rests may not be used

2. Sights

- a. Any sights may be used, including scopes.

3. Target and Distance Options

- a. A-17 or A-32 target at 50 feet, two shots per bullseye.
A-23/5 or A-31X target at 50 yards, five shots per bullseye.

4. Course of Fire Options

- a. Shooters may qualify for rimfire rifle ratings using any one of the three courses of fire available: prone or benchrest, all standing, or 3-position (prone, standing and kneeling). Body and/or gun support may be used at the Pro-Marksman rating level in all courses, and throughout the prone/benchrest course.

5. Must shoot Marksman level. (chose one of the options a, b or c to complete requirements)

- a. Prone or Benchrest
 - i. Shoot two targets
 - ii. 20 shots each
 - iii. Score 125/200 or better

b. Standing

- i. Shoot six targets
- ii. 10 Shots each
- iii. Score 50/100 or better

c. 3 Position- prone, benchrest and standing

- i. Shoot two Targets
- ii. 10 shots each position
- iii. Score 150/300 or better

Shotgun

1. Shotguns

- a. Any safe shotgun, 12-gauge or smaller, may be used. Different gauges and different guns can be used for any round or rating.

2. Position

- a. Shooters have the option of mounting the shotgun on the shoulder before calling for the target.

3. Ammunition

- a. Any shotgun ammunition, factory or reloads, may be used. Be sure to check with the range or club for local ammunition restrictions. (Maximum 1 1/8 oz., No. 7 1/2 shot or less, or as specified in the rulebooks.)

5. Targets

- a. Standard clay targets are used.

6. Must shoot Marksman level (complete either a or b to complete requirements)

- a. Skeet or Trap Course
 - i. Break 13 out of 25 clays or better four times
 - b. Sporting Clays or 5 stand
 - i. Break 16 out of 50 targets or better four times

Muzzle Loading

Rifle: Any safe muzzle loading rifle may be used.

1. Percussion rifles may use any projectile.

2. Any metallic sight is allowed.

3. Shotgun: Any safe single- or double-barrel muzzle loading shotgun, any gauge, that uses percussion cap ignition, may be used.

4. Accessories: Slings, palm supports, cross-sticks, loading tubes, shooting coats and gloves as described in the NRA Muzzle Loading Rifle and Shotgun Rules may be used.

5. Targets

- a. Rifle: B-19 25 yds. or B-17
- b. Rifle: B-6 50 & 100 yds.
- c. Shotgun: standard clay targets are used for shotgun.

6. Powder

- a. Only black powder or BATF-approved substitute may be used.

7. Scoring

- a. All ratings are 10 shot courses of fire.
- b. Due to the variation of calibers used, scoring is done relative to the center of the ball or bullet hole. The center of the shot hole must at least touch a scoring ring to count that value. There are no time limits for completing a target.

8. Must shoot Marksman level (Choose a, b or c to complete requirements)

- a. Muzzle loading Musket and Rifle
 - i. Prone or benchrest 50 yards
 - ii. Shots best 10 of 13
 - iii. Score must be 45 or better
 - iv. Must do this two times
- b. Muzzle loading Shotgun (choose either I or ii to complete requirements)
 - i. Skeet
 1. Two targets at each station, singles, only.
 2. Must shoot 7 out of 16 clays or better
 3. Do this two times
 - ii. Trap
 1. 15 rounds, 3 targets each at station moved to within eight yards of the trap house.
 2. Must shoot 6 clays out of 15 or better
 3. Do this two times
 4. 15 rounds, 3 targets each at station moved to within eight yards of the trap house.

Archery

1. Recurve

- a. Indoor
 - i. Shoot 30 arrows at 18 meters on a 60-centimeter five color target.
 - ii. You must score 130 out of a possible 300 points
 - iii. This is CAA Bowman First Class
- b. Outdoor
 - i. Shoot 30 arrows at 30 yards on a 122-centimeter five color target.
 - ii. You must score 130 out of a possible 300 points.
 - iii. This is CAA Archer First Class
- c. Shoot 30 arrows at 18 meters on a 40-centimeter five color target.
- d. You must score 130 out of a possible 300 points
- e. This is CAA Bowman First Class

2. Outdoor

- a. Shoot 30 arrows at 40 yards on a 122-centimeter five color target.
- b. You must score 130 out of a possible 300 points
- c. This is CAA Silver Bow First Class
